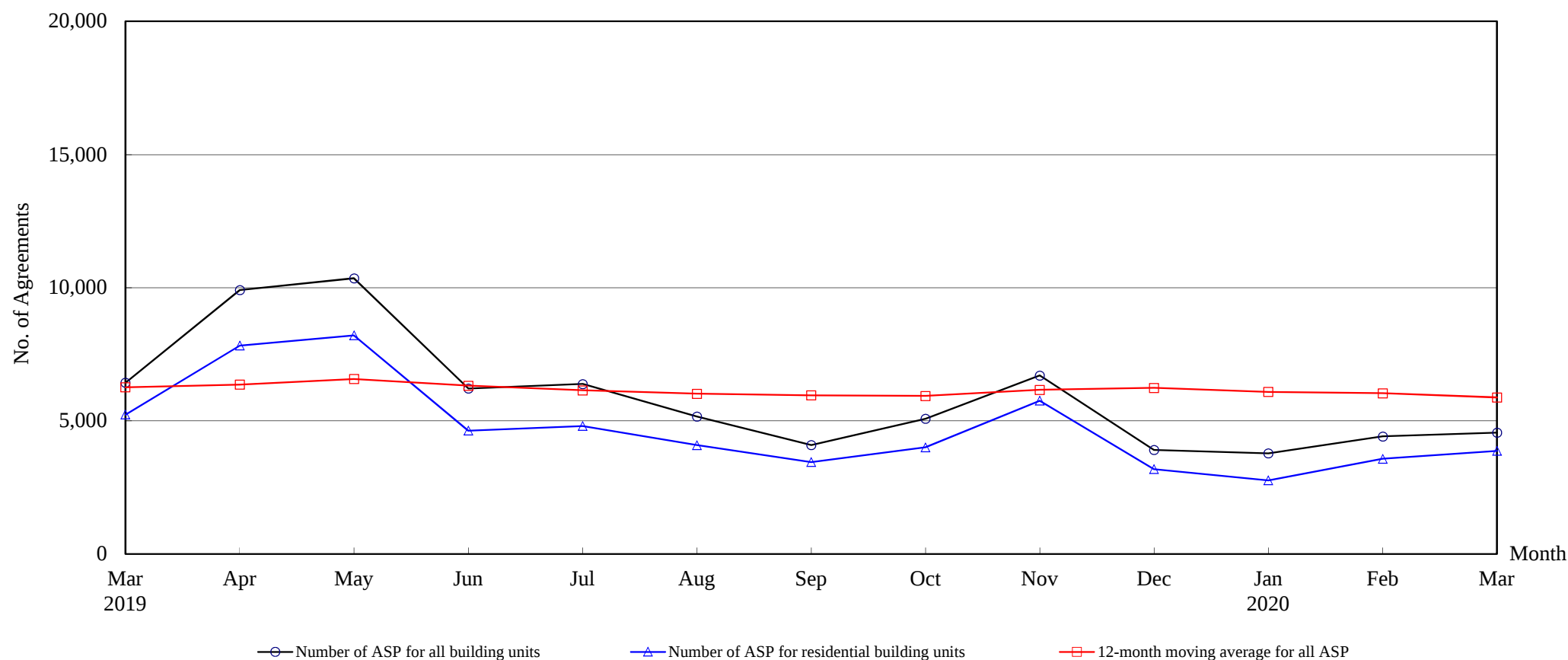

building units from March 2019 to March 2020



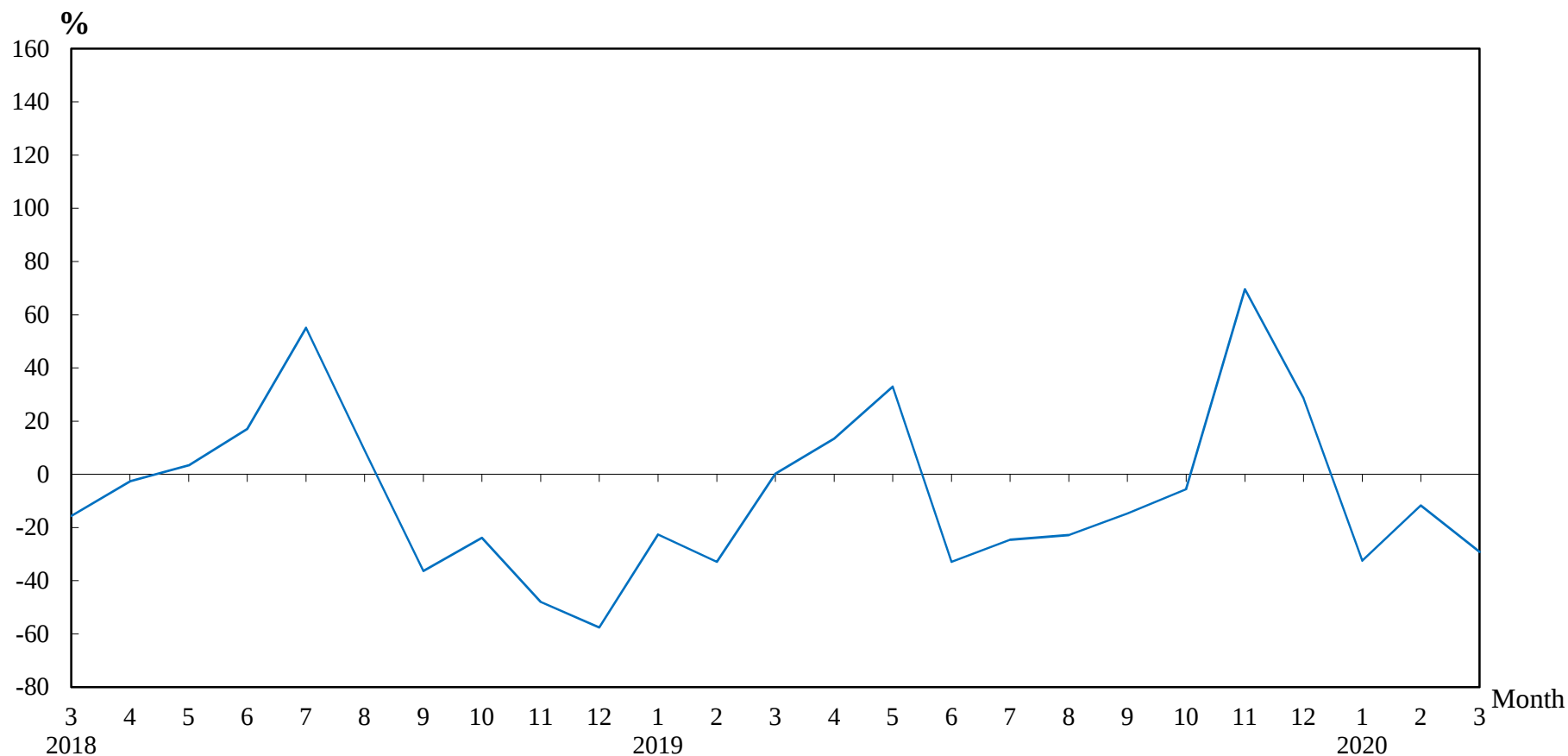
